Introduction

As Chair of the Governing body, it is my pleasure and privilege to introduce this report to you.

This year has been a strange year, we started off the Christmas Term and the first half of the Spring Term as normal then Covid-19 struck. Schools were left with trying to ensure all pupils were educated and safe during the lockdown. In the early days there were real concerns about how badly this pandemic may affect everyone in the community. Pupils with free school meals and children that required extra assistance, how would we be able to help them. The school along with all the others in Swansea worked extremely hard to address these issues.

Then came the worries about the external exams. Pupils were extremely concerned that they had not had enough time to prepare. The announcement that the exams had been cancelled brought welcome relief to them. Unfortunately, we then had the problem with the results which brought more anxiety. This was finally resolved and I would like to pay tribute to the staff who had to deal with all the challenges this brought. They worked extremely hard to ensure that the pupils were given a grade that reflected the amount of work that the pupils had put in.

We then had a return to school, originally, we were told 4 days then it went down to 3 days. The school had to adapt to make sure that pupils and staff would be safe. These were called "check in days" as there was limited time for teaching but it was also a way of checking a pupil's welfare.

In the summer term apart from exams there is usually a transition week for Y6 pupils that are intending to come to Olchfa. Once again staff came to the rescue and produced a video. This was well received by many parents/carers with the school receiving many compliments. Finally, I would like to thank my fellow Governors for their support during this time, Mr Davies for his leadership and communication throughout this pandemic and all the staff and pupils for making Olchfa as safe and successful as possible in these difficult times.

I am proud to be Chair of a school that has shown so much commitment and dedication during these difficult times.

Governing Body Meeting with Parents

A letter from the Chair of Governors setting out how to request a meeting with the Governing Body was distributed to all parents/carers in October 2020. The text is reproduced below. (No meeting with parents was requested/held in the academic year 2019-2020.)

October 2020

To: Parents/Carers of Pupils at Olchfa School

Your right to request a meeting with the school's Governing Body

The Schools Standards and Organisation (Wales) Act 2013 (The Act) removed the requirement for school governing bodies to hold an annual meeting with parents. Instead, new arrangements were introduced to enable parents to request up to three meetings in any school year with a governing body, on matters which are of concern to them.

If parents wish to use their rights under the Act to hold a meeting, four conditions will need to be satisfied:

1. Parents will need to raise a petition in support of holding a meeting.

The parents of at least 10% of the school's registered pupils_will need to sign the petition. If it is a paper petition, then a written signature must be given as well as the name and class of each child who is a registered pupil at the school. If the petition is in electronic format, the 'signature' required is the typed name of the parent plus the name and class of each child who is a registered pupil at the school and the email address of each parent who 'signs' the electronic petition.

There were 1799 children registered as pupils with this school at the beginning of this academic year. Exact roll numbers at any time during the year may be obtained from the school office.

2. The meeting must be called to discuss matters which affect the school

The meeting cannot be called to discuss such matters as the progress of individual pupils, or to make a complaint against a member of the school's staff or governing body.

The petition should contain brief details of the matter(s) to be discussed, and the reasons for calling the meeting. This information should be clearly displayed at the top of the petition, with parents' signatures appearing below.

3. A maximum of three meetings can be held during the school year

The law allows parents to use their rights to request up to three meetings with a school governing body during the school year.

4. There must be at least 25 school days left in the school year

The law makes it a condition that at least 25 school days are left in the school year when the petition is received so that the meeting can be held.

A "school day" means a day when the school is open to pupils: it does not include weekends, public holidays, school holidays or INSET days.
